If the Client or his representative handles the investments, only gilt-edged fixed-rate direct investments (such as federal and cantonal bonds, or certificates of deposit and time deposits with Swiss banks) and collective investment funds regulated by FINMA or approved by it for distribution in Switzerland or issued by Swiss investment funds are authorised.
